REQUIREMENT TO KEEP THE CARD VALID: + Invest from 350,000EUR++ into one of the projects in Portugal + Stay 7 days/ year in Portugal + Submit civil documents and criminal record to Immigration and Service borders at the time of renewal the card TOTAL COST TO RECEIVE THE CARDS Family size: 4 members Investment: 350,000EUR Government and related fee: 85,000EUR ** **Government fee can change due to different family size and update table cost from the government.
